PLANNING APPLICATION FOR THE GRANGE WIND FARM SUBMITTED

7 wind turbines proposed between Sutton Bridge and Tydd St. Mary

RES has submitted a planning application to build a seven turbine wind farm between Sutton Bridge and Tydd St. Mary. The 14MW wind farm site lies on agricultural land on Tydd St. Mary's Marsh.

The planning application has been submitted to South Holland District Council, who will commence a consultation process with the local community and interested parties. A decision on the application is expected in the autumn.

Each turbine would have an indicative capacity of 2MW, and a maximum height to the tip of the blade of 127m. The wind farm would generate enough pollution-free electricity a year to meet the annual electrical demand of over 8,000 average homes, equivalent to 24% of the annual consumption of all the houses in the South Holland district.

Helen Hall, Project Manager for the Grange Wind Farm proposal, commented;

"We are really pleased to see just how much support there is for this wind farm in the area. We have been told that the wind farm will be an important landmark locally and we have already had a great deal of interest in the benefits that the £28,000 per year community fund will bring to the area. The wind farm will provide much needed green, sustainable energy to contribute to the UK's energy security and carbon reduction targets and provide valuable jobs and economic growth."

RES circulated a leaflet containing details of the plans to over 6,000 homes in March and held exhibitions in April.

Dave Kerr, who lives in Sutton Bridge, added, "I would be really pleased to see this wind farm built. Wind turbines are really relaxing to look at and give us clean green energy without needing fossil fuels."
